

1. Foreword

In this document there are the terms and conditions governing the purchase of products sold by the site www.naticonlacamicia.org.

In order to proceed with the purchase of one or more of the products offered on the pages of the site the user is asked to enter his billing and shipping details of the goods and accept these Terms and Conditions of Purchase.

If you have already made a purchase earlier and have therefore already accepted these Terms and Conditions of Purchase, you can make the purchase of a product or products sold through the Site after you have entered your email and password, password assigned to the time of first purchase on E-commerce website. In this case, the Conditions of Purchase accepted at the time of the first purchases must be understood as applied equally to purchases made as a result. The acceptance of the Terms of Purchase constitutes basic prerequisite in order to finalize the purchase of any product on the pages of this Site.

2. Service Provider information

The marketing activity of goods offered for sale on the pages of the Site is done by Naticonlacamicia.org of Davide Trevisani, which is responsible for sales via the Internet of some of the products in the store in Via Garibaldi 56-44121 Ferrara (FE) .

3. Methods of conclusion of the contract

The consultation of products

Consulting the pages of the Site and clicking on the icons corresponding to the articles, you can easily "navigate" in the virtual catalogue of the goods marketed by Naticonlacamicia.org.

The choice of the products and Cart

Once you have located an object of interest and liking, you can see its features by clicking on the image or 'details' link. If the product is shown as available, the user can start the purchase process by clicking on the basket icon, located next to the selected product. In this way, the user enters in his shopping cart

the number of desired goods. The inclusion of the product in the shopping basket does not commit you to buy it, as you are free to remove it or change the quantity.

In case that you are not already registered, you must register by following the procedure described below, providing your personal information.

If you wish-to obtain a list of objects placed in your cart, it will be sufficient for you to click on the icon at the top on the right of the page GO TO CART.

Registration

Once you've chosen a product, to proceed with the purchase you must register, or - in the case of already registered - enter your email and password. If you have forgotten the password, you have the chance, clicking on the link below the login form, and entering your email address into the field of research, to get your password to the e-mail address provided during the registration.

At the first registration, you will be required to accept the Terms and Conditions of Sale, which will be consulted on the pages of the Site and, through special links placed on pages E-commerce, can be reviewed at any time. The acceptance of the Terms of Purchase must be made by clicking on the I AGREE, located in the registration form.

Upon registration, the user will have to enter a series of personal data and information strictly necessary for the purchase and delivery of the product.

Delivery and invoicing modes

The individual modes of delivery are subject to specific treatment in these Terms of Sale.

The summary of the order, the choice of the mode of payment and forwarding to Naticonlacamicia.org

By clicking on the "Finish Order", you access a page that contains a summary of all data relating to the purchase that you will make. After carefully checking the correctness of the information given, you choose the mode of payment that want to adopt, complete the required fields depending on the type of payment chosen, and transmit the order to Naticonlacamicia.org, clicking on the "Order ".

Input error correction

Up to the time in which the order is transmitted to Naticonlacamicia.org, you are always able to change the contents of the data entered, either directly on the page where it is located, or by clicking on the

"View Cart" that allows you to return to the page that displays the contents of the basket in order to correct any errors in data entry.

The items in the shopping cart can be removed before sending the order by clicking inside the cart summary page on the "X" icon and Delete link on the product.

The order confirmation

Naticonlacamicia.org will promptly send to the e-mail address provided by the user a receipt containing a summary of the general and special conditions applied to the contract, the information on the essential characteristics of good, detailed indication of price, terms of payment, the right of withdrawal, delivery costs and taxes that may be applied.

Conservation of order

The contract will then be archived and preserved by Naticonlacamicia.org in the archives. You can access it by sending, by fax or e-mail, a request to Naticonlacamicia.org; entering or logging into the Customer Area with your email and password assigned and clicking on "View Order" in the pages Ecommerce business; doing so the user examines all his orders from the E-commerce Naticonlacamicia.org seeing in real time the status of the order.

4. RULES OF PAYMENT

Users have the option to choose one of the following payment methods:

- Wire transfer;
- Delivery note;
- Credit Card (PagOnline Unicredit);
- Credit cards (PayPal).

Wire transfer

The bank transfer must be made within three (3) days of receipt of the current e-mail confirmation of the order, only in Euro currency, using the bank account details sent in the confirmation e-mail of the closure order. The description of the transfer will necessarily include the code assigned to the order and the date. These data are reported in the confirmation e-mail that Naticonlacamicia.org sends you after placing the order.

It is expressly understood that the order takes effect and the products will be shipped only when Naticonlacamicia.org receives the sum due by the client on his bank account. In this regard, Naticonlacamicia.org points out that the time currently required by the banking system for crediting the beneficiary account can vary from three to five working days from the date of disposal.

Delivery note

By choosing this method, users pay directly the courier by the delivery of the product. Clients can pay with banknotes and/or coins that match the exact amount, as the carrier is not required to deploy any rest. Payments by bank cheques or draft aren't allowed.

The payment on delivery is subject to a surcharge of 10,00 Euro. However, in order to use this form of payment, by the order you must provide the telephone number of the recipient, the same person who will pay the delivery note.

Credit card

Users can choose to pay by credit card. The choice of this form of payment does not require the application of any surcharge on the total price resulting from the order. However, the following conditions must be fulfilled:

- The order should be registered to the credit card holder and the credit card must be attributable to the company

The payment made by credit card is carried out in a completely safe condition. The data of the credit card are, in fact, transmitted by the user in an encrypted form on the server PagOnline UNICREDIT, which handles the entire transaction.

Naticonlacamicia.org is aware of only the final outcome of the transaction.

Credit card (PayPal)

The user can choose to pay by credit card VISA or MASTERCARD. The choice of this form of payment does not require the application of any surcharge on the total price resulting from the order. However, the following conditions must be fulfilled:

- The order should be registered to the credit card holder;
- The goods can be shipped only to the address of the credit card holder;

- At the time of registration, the owner must necessarily indicate the number of his landline phone corresponding to the address where he can be reached for verification;
- Only if you indicate your mobile phone number, Naticonlacamicia.org reserves the right to contact the customer to request a copy of the document to be faxed.

The payment made by credit card is carried out in a completely safe condition. The data of the credit card are, in fact, transmitted by the user in an encrypted form on the server PAY PAL, which handles the entire transaction. Naticonlacamicia.org is aware of only the final outcome of the transaction.

5. Delivery of Products

Shipping to Italy

Naticonlacamicia.org makes the delivery of products purchased through the Website to all the following countries: Italy, courier DHL.

The indicative timing of delivery of the products is equal to 1 working day (24 hours) from the day following the date of receipt of payment if the recipient of the goods is located in Italian territory, except for Sardinia, Sicily, Calabria and European countries where it will take 2 working days (48 h). Upon receipt of the goods, the buyer is required to verify that the package is intact and that the number of packages matches those shown on the invoice and shipping documents. Any inconvenience concerning the delivery must be raised immediately to the carrier.

Shipping Abroad

Naticonlacamicia.org makes the delivery of products purchased through the Site using courier DHL.

The indicative timing of delivery of the products abroad is from 1 to 7 working days, starting the day following the date of receipt of payment. Upon receipt of the goods, the buyer is required to verify that the package is intact and that the number of packages matches those shown on the invoice and shipping documents.

6. Product availability

The products on this site are ready for delivery. However, the Customer takes acknowledge of the remote possibility that when the order is delivered the product may no longer be available. In this case, after confirming the order by e-mail, Nati Con La Camicia will inform the customer with a new e-mail and the order will be cancelled.

In addition, any offers on this site are valid only for online purchases.

7. Withdrawal

Pursuant to Article 5 of Legislative Decree 22 May 1999, n. 185, the consumer has the right to terminate the contract, returning the purchased product and getting a refund of the sums paid.

Only people who have completed the contract by acting for purposes not related to their professional activities may exercise this right.

In order to exercise the right of withdrawal, the consumer must send to the head office of Naticonlacamicia.org, within ten (10) working days from receipt of goods, a registered letter with acknowledgment of receipt, written on the basis of the facsimile that can be downloaded by clicking on the following link declaration of withdrawal template.

The notice may also be sent, within the same period, to Naticonlacamicia.org, by telegram, telex or facsimile, provided that it is confirmed within the next forty eight (48) hours by registered letter with acknowledgment of receipt to the head office of Naticonlacamicia.org.

Within 3 (three) working days from receipt of the notice described above, Naticonlacamicia.org will send to the e-mail address provided by the user at registration a special code to identify goods on their return (henceforth, referred to as the "Return Code").

The user is asked, at its own expense and within seven (7) working days from receipt of the Code of Return, to send to the head office of Naticonlacamicia.org goods, in original packaging, complete with all accessories, its manuals and any other item received.

The user must also indicate on the packaging of the goods, the number of assigned Return.

After checking the integrity and completeness of the goods received, Naticonlacamicia.org will credit the consumer with the sum paid. These amounts will be paid by bank transfer to the bank account notified by the consumer in the communication in which he has declared that he intends to exercise the right of withdrawal.

Refund will be free as soon as possible and, in any event, within thirty (30) days from the current date Naticonlacamicia.org became aware of the right of withdrawal by the consumer.

That being said, it is expressly understood that Naticonlacamicia.org will not be required to pay any amount before the receipt of goods in relation to which the consumer has exercised his right of withdrawal.

It should also be said that for an error of assessment (number / colour) or portability due to the good faith of the customer, the costs of returning and resending the same article, are at the expense of the customer. The return will happen when the shipping charges will be collected by bank transfer or by Paypal Naticonlacamicia.org

8. Guarantee in respect of defects in non-compliance

Pursuant to Articles 1519-bis of the Italian Civil Code, Naticonlacamicia.org is responsible to the consumer in relation to any lack of conformity which exists at the time of delivery of the goods

9. General clause

All amounts contained in these Terms and Conditions are inclusive of VAT
